# Introduction

## ► Ministry of Health (MoH)

-Central role in the health system, through its responsibilities for formulating health policies, exerting influence and collecting and using intelligence for development, implementation and monitoring of health policies and enforcing health legislation.

The MoH roles are:

- establishing overall strategic direction and priorities for the health system;
- developing legislation, regulations, standards, policies, and directives to support those strategic directions;
- monitoring and reporting on the performance of the health system and the health of population;
- planning for and establishing funding models and levels of funding for the health care system; and
- ensuring that ministry and system strategic directions and expectations are fulfilled (especially with the state-budget funded programs, where MoH is directly involved in their implementation)



# Introduction

## ► Ministry of Health



**The main responsibilities (as per the Law on organization and performance of the state administration bodies) are activities related to:**

- **Health care and health insurance**
- **Organization and development of health system**
- **Monitoring of the health status of population**
- **Protection of population against communicable diseases, harmful effects of gases, ionizing radiation, noise, air, water, contaminated soil, chemicals, narcotics, hygiene and an epidemic**
- **Hygiene-epidemiologic condition**
- **Chemicals and narcotics**

**In 2015- special body “E-Health Directorate” was established within the MoH. It is responsible for development and improvement of the integrated healthcare information system “Moj Termin”**
